# **WELCOME**

Dear Friends and Colleagues:

Bienvenidos a Puerto Rico and welcome to the sixth Public Health Law Research Annual Meeting!

With the continued generous financial and programmatic support of the Robert Wood Johnson Foundation, we meet once again to present research, improve research methods, and enhance our capacity to make the evidence for public health law more accessible to policymakers, the media, and the public.

Since 2009, PHLR has funded more than 80 grants to researchers as they investigate the ways laws influence public health. This year, we welcome nine new grantees. Their research delves into the emerging issues of e-cigarettes and fracking, and carries on previous work understanding laws aimed at preventing concussions in youth sports and bolstering school vaccination requirements.



We continue to support the creation of high-quality legal datasets for the public domain. LawAtlas has blossomed. Our staff has grown to include more than 15 legal researchers. The site now hosts more than 30 datasets, and the Workbench is being used by a wide variety of partners, including researchers, state and local health departments, and CDC projects. Together, we are proving that policy surveillance is not only feasible, but is a vital tool for public health.

This year's meeting theme, Law in a Culture of Health, is rooted in the Robert Wood Johnson Foundation's new guiding principles. Law permeates culture. It exists in our behaviors and beliefs at all levels of social organization: in neighborhoods, schools, workplaces, towns, and regions as well as at the national level. It sets rules that define minimum standards of behavior, expressing social expectations and disciplining violators. But law also affects behavior indirectly, as others observe the new behavior, perceive its feasibility and beneficial consequences for health, and then adopt it as their own. Over time, the legal rule becomes a behavioral norm. On Friday, you will be asked to share your idea for how law can be used to build a culture of health within the Foundation's new framework. We look forward to hearing your ideas as we explore this new direction.

We are excited to be here in beautiful San Juan, Puerto Rico, and extend our thanks to our hosts at the Sheraton and those at the University of Puerto Rico who have welcomed us. José Cordero, MD, MPH, is the Director of the Institute of Public Health and Genomics. He joins a panelist during our plenary on Thursday along with Dr. Brenda Rivera, State Epidemiologist at the Puerto Rico Department of Health, and Dr. Wanda Maldonado, Dean of the School of Pharmacy at the University of Puerto Rico, Medical Sciences Campus. Jewel Mullen, MD, MPH, MPA, Commissioner of the Connecticut Department of Health, is our keynote speaker on Wednesday afternoon. We are delighted and honored to have them join us to share their knowledge and experiences.



# SPEAKER BIOGRAPHIES

# **Keynote Address**

Jewel Mullen, MD, MPH, MPA

Commissioner, Connecticut Department of Public Health

Dr. Mullen's keynote address will explore public health law and its evaluation through the lens of a state public health commissioner. She will discuss current issues facing Connecticut and its communities and the role of law in addressing those concerns.

As commissioner of the Connecticut Department of Public Health, Dr. Mullen oversees the state's leading public health agency. Dr. Mullen was appointed to this position by Governor Dannel Malloy in December 2010. Prior to joining the department, Dr. Mullen was director of the Bureau of Community Health and Prevention at the Massachusetts Department of Public Health. Dr. Mullen previously served as the medical director of Baystate Mason



Square Neighborhood Health Center in Springfield, Massachusetts. Board certified in internal medicine, Dr. Mullen received her Bachelor and Master of Public Health degrees from Yale University where she also completed a post-doctoral fellowship in psychosocial epidemiology. She graduated from the Mount Sinai School of Medicine where she was elected to AOA, the National Medical Honor Society, after which she completed her residency at the Hospital of the University of Pennsylvania. She also holds a Master in Public Administration degree from Harvard University's John F. Kennedy School of Government.

# Thursday Plenary Session

Unintended Consequences of Legislation and Opportunities to Build Coalitions

Join Drs. Jose F. Cordero, Brenda Rivera and Wanda Maldonado as they discuss the unintended consequences of the Puerto Rico Medicine Cabinet Law. The intent of this law was to set standards for storing drugs and biologics and facilities that would ensure its integrity and safekeeping. This is an important and critical element of the health care system, but at the time of translating this law to regulatory rules, the scope of facilities covered under the law included storage of vaccines and drugs in medical offices. This decision meant that medical offices were subject to the same requirements meant to large distributors of vaccines and drugs, such as backup generators able to work for at least 72 hours, a very costly investment. Many permits were also required, as well as a site inspection prior to issue the license, what made it a lengthy process. This was a deterrent for many physicians to store vaccines in their offices and the number of practices that offered immunization services plummeted. As a result, immunization coverage levels among young children declined markedly. Many attempts to amend the law failed for many years. Finally, a coalition of nearly 20 organizations was convened in 2014 and successfully developed a consensus proposal that balanced the need for standards for storing drugs and biologics and facilities with the need for access to immunization services through a simple process for medical offices to store vaccines for children and adults. The proposed law passed unanimously in both chambers of the Puerto Rico legislature and was signed into law in 2014. Its enactment already has had the desired impact in increasing the access to immunization services at medical offices.
