## **EFFECTIVE DATES**

An effective date is the date a law goes into effect. To create an accurate study, it is essential to include effective dates for each law within the project. Typically, effective dates can be found in three places: 1) within the text of the law itself, 2) in the beginning of chapter where the law lives, 3) or the beginning of the entire title book that houses all the laws passed in a legislative session. The effective date is not to be confused with the passage date, signature date, or date of approval, which are indicators of other steps in the legislative process, although the dates may be the same. For example, the governor signs a bill on February 1, 2015 and it goes into effect upon signature, thus, the effective date is the same as the signature date - February 1, 2015.

When performing your project, you can use other dates such as approval or operational dates, if they fit the goals of your project. However, we recommend using effective dates when doing policy surveillance.

Regulations are rules passed by administrative agencies. While each agency may set its own guidelines for the process, the basic requirements are usually included in a statute referred to as the Administrative Procedures Act.

The date calculator can be used when a state indicates that the effective date is a certain number of days or months after another step in the legislative process. For instance, in Utah, legislation becomes effective 60 days after adjournment of the legislative session, unless otherwise specified.

Legislative adjournment dates: Adjournment dates are included in the session law compilations available through Hein Online. They are also available on each state's legislative website.

Legislative adjournment dates are sometimes necessary to determine effective dates as well, as in the Utah example.

Default State Effective Date Rules: If a law does not list the effective date in the places described above, then you can use the table below to find the effective date.

Pennsylvania	The effective date is specified in the legislation.
Rhode Island	The effective date is specified in the legislation.
South Carolina	Legislation becomes effective 20 days after approval by the Governor, unless otherwise specified in the bill text.
South Dakota	The state Constitution provides that no law can take effect sooner than 90 days following the legislative session. In addition, existing state law sets the effective date of bills passed during the regular session at July 1, unless the new law itself lists a later effective date (SDCL 2-14-16). The exception to this is a law that contains an emergency clause.
Tennessee	Legislation becomes effective 40 days after its passage, unless otherwise specified in the bill text.
Texas	Legislation becomes effective 90 days after adjournment of the session at which it was enacted, unless otherwise specified in the bill text. Texas State Constitution, § 39, Art.
Utah	Legislation becomes effective 60 days after adjournment of the session, unless otherwise specified in the bill text.
Vermont	Legislation becomes effective on July 1 after adjournment of the session, unless otherwise specified in the bill text.
Virginia	Legislation enacted at a regular session becomes effective on July 1 following adjournment of the session at which it was enacted, unless otherwise specified in the bill text. Legislation enacted at a special session shall take effect on the first day of the fourth month following the month of adjournment of the special session, unless specified otherwise. Virginia State Constitution, Art. IV, § 13.
Washington	Legislation becomes effective 90 days after adjournment of the session, unless otherwise specified in the bill text.
West Virginia	Legislation becomes effective 90 days after its passage, unless otherwise specified in the bill text.
Wisconsin	Legislation becomes effective one date after the date of publication, unless otherwise specified in the bill text.
Wyoming	The effective date is specified in the legislation. For regulations, according to 16-3-104, the regulation is effective when it is filed, unless otherwise specified.
